Drugs, Alcohol, Opioids

Greg Knell and Mark Dale presented the committee with an overview of RxSafe Marin, a community-based coalition that addresses the problem of prescription drug misuse and abuse in Marin County. RxSafe Marin brings together partners in law enforcement, prescribers, pharmacists, educators, elected officials and family members affected by the issue to develop strategies that work.

- ◆ Recommended areas for collaboration include:
  1. Expand parent guide program to Marin County middle schools and partner in sharing the costs of the program
  2. Introduce the online Alcohol & Drug Class into Marin County high schools and partner in sharing the costs of implementation
  3. Consider making Naloxone (also known as Norcan) available on school campuses
  4. Partner in coordinating parent/education nights to bring a common message to all campuses
  5. Prospect of working with the Marin County School Boards Association (MCSBA)

The guidebook is currently in draft form and once finalized will be available countywide.

Dear Marin County School Community:

The Marin County school community joins our nation in mourning the seventeen teenagers and school staff whose lives were tragically lost at Marjory Stoneman Douglas High School in Parkland, Florida. No community should ever have to experience such a devastating loss. It is our hope that from these unthinkable circumstances, positive change can occur through civic and legislative action.

In recent weeks our nation has witnessed a student-led call to action to prevent gun-related violence from occurring again. We are proud to stand with the students of Marjory Stoneman Douglas High School and ALL students nationwide who demand action. These are the students who have grown up in a world where lock-down drills and headlines about yet another gun-related tragedy are the norm. We are proud of our young leaders who are exercising their right to advocate for stricter gun control laws. They are our future and they refuse to stand on the sidelines.

These efforts have resulted in nationwide planned days of action in the month of March:

- Wednesday, March 14 at 10:00 a.m. – The National School Walkout will take place for 17 minutes to commemorate the 17 victims of the Parkland shooting.
- Saturday, March 24 – The March for our Lives will take place in Washington, D.C. and is sparking local marches in solidarity, including one in San Francisco.

Since March 14 falls on a regular school day, Marin's school leaders are working closely with our students and law enforcement to devise the best strategies for supporting our students' rights and above all ensuring that our students are safe. Individual schools/districts may have different strategies which will be conveyed to students and parents.

This advocacy effort is an example of democracy in action. Our students are exemplifying civic responsibility and using the rights provided in our Constitution to incite change. We are proud to see our youth leading these efforts and we support the ultimate goal of keeping our schools and our communities free from gun violence.

## **Marin Voice: Marin teens want to be heard about our schools**

Leadership takes a variety of forms for Marin County teens; and many have developed leadership skills on their school campuses, in their classrooms and through extracurricular programs.

Educators work tirelessly from within the existing school structure to cultivate leadership in their students. Whether planning an election, peer tutoring, peer mentoring, individual goal setting, or using restorative justice protocols to help a peer get back on track, our schools are filled with young people eager to serve their fellow students, develop personal agency and grow their potential as future leaders.

In the debate for the best ways to create conditions in our schools that allow for them to thrive and succeed, the voices which need to be heard the most — student voices — are often ignored.

As educators of these future leaders, we know we must be purposeful about listening to young people, and to place young people in central roles for designing and implementing solutions that will work for them and their peers.

So the first annual Marin Student Leadership Summit Retreat was born. Amazing students and incredible advisers came together for a weekend in February to learn, collaborate, and articulate some of their goals and their ideals.

The below value statements, developed at the retreat by the student leaders themselves, showcase the incredible passion and focus of Marin's student leaders. As just a few of their educators, we are proud to have witnessed the collective power of their voices.

“We represent various leadership programs on our campus — Student Government, Link Crew, Peer Resource, AVID, Wellness, WISE Mentoring — that each work to improve the climate and culture of our schools. After a weekend at Walker Creek (just four days prior to the school shooting in Parkland, Florida) where we discussed important issues facing our school communities, including equity, race, opportunity, physical safety, and social and emotional health, we recognize the power of our collective voice to impact our school campuses.

“We are over 150 student leaders from Tomales High School, Novato High School, Terra Linda High School, San Rafael High School, Marin Catholic High School, Sir Francis Drake High School, Redwood High School and Tamalpais High School.

“We come from different communities. We have different mascots. But we all believe that students deserve places to learn where they are safe, valued and respected.

“We understand that many will assume that due to our age we are emotional and uninformed. This is untrue. We are educated and versed in the issues that continue to disrupt the fabric of our education. We are future voters, future parents and future leaders of this country and we will be heard.

“Nationwide (March 14), our generation will take what we have learned in our schools about being passionate, proactive and involved citizens and we will use our voices to speak our frustration and fears we have around the issues that directly affect our lives on our school campuses.

“We commit to being engaged as student leaders in Marin on our collective campuses to address the issues we care about. We will work together across our county to do this. We will speak with volume.

“We will act with conscience and we will engage civilly and civically.



“Hear us. Watch us. Support us.

“Below are our shared beliefs which we affirm to honor and implement. We commit to elevating the discussion and continuing to push for courageous conversation to that end.

“We believe that our schools should:

“• Provide a sanctuary for learning; where in every hallway, and in every classroom we have no fear for our physical safety, every day.

“• Be places where there is equity — all students should have a voice and access to quality education and academics.

“• Celebrate our differences.

“• Encourage and provide resources for self-care, social and emotional health, and wellness.

“• Be inclusive in places that cultivate positive climate and positive culture, and where students feel a sense of belonging.

“• Be a place where respect drives relationships between students, between students and teachers, and between students and administrators.”
